8. General business

8.1 GCA annual grant

The GCA receives a grant of \$5750 inc gst from QLDC for the year 1 July to 31 June. The committee will consider funding priorities for the year at this meeting and suggestions from the community are welcome. Items for consideration include:-

Vegetation clearance and planting at the waterfront Picnic tables waterfront area Footpath from wharf shed to lagoon walk entrance

8.2 Wastewater meeting

The GCA held a constructive public meeting for QLDC to update us on community wastewater management. Work is underway to establish a baseline of the effects that our existing treatment methods have. Desktop assessments will be compared with site samples and a call for volunteer sites has been made via the community website.
