#### 7. General business

#### 7.1 GY Pool update

To date 1200 swimmers through the pool. Cleaning robot due to be fixed under warranty. General good behaviour in the pool. Wishlist for the next season would be wifi monitored dosing machine, replace clear lite roof and wall sheets, auto filler, upgrade return flow pipe and add vents in ends of building as too much debris comes in through roof. A pool report will be sent to QLDC.

#### 7.2 GY Kids collective

A meeting is scheduled to update the brief to the architects following community feedback to make the scheme more in keeping with GY after which there will be more community consultation.

#### 7.3 GY airstrip proposed increases in landing allocations

The committee are comfortable with increases to allocated landings as these are still below pre 2019 levels. We will advise QLDC that we consider there should however be no more increases until the reserve management plan is updated.

# 7.4 Cantire St - discussion on merits of modifying to one way traffic adjacent to the pool & school.

The committee agreed that this should be added as an agenda item at the March meeting.

#### 7.5 Frequency of grading gravel roads at the head of the lake

# 7.6 Freedom camping - issues?

# 7.7 ORC Head of the Lake adaptation strategy - GCA position on recommendations.

The committee considered that the economic assessment was inadequate, the risk assessment needed more work and that there should be further engagement as and when any planning rule changes were proposed. The committee asked that the cost of the process of consultant reports should be requested.

### 8.0 Any other business

A suggestion had been made that the wooden "welcome to Glenorchy" sign was now somewhat dated and should be replaced. This will be added to the agenda for the March meeting.
