8.1 Update on airstrip environment court hearing - parties involved could not reach agreement a new the court will issue a ruling in due course.

8.2 Refurbishment of rec ground tennis court - the court will be modified to enable a full size netball court to be accommodated within the fenced enclosure.

9.1 QLDC proposed 10 year (Long Term) Plan and Spatial Plan

Representatives from Council will be present to introduce these plans, identify what they mean for Glenorchy and answer our questions in order to ensure the community can make informed submissions should they wish to.



The committee will discuss and agree the substance of the GCA submission after the departure of the council staff

9.2 GCA representative on the airstrip consultative committee

The GCA was previously represented by Robert Bakhuis. A replacement is now needed and the role will be discussed at the meeting

9.3 Pool update

The pool has now closed for the season and the committee will agree how best to reward those who have worked hard to keep the pool running. The meeting will consider what repairs / improvements to undertake over the winter and how to fund these.

9.4 Request to establish a Glenorchy Zero Waste subcommittee of the GCA

A group has formed and met and wishes to be a subgroup of the GCA until such time as it is ready to be set up as an independent organisation. This will assist with funding applications etc at this stage.

9.5 Application to DOC for a concession to remove gravel at the Bucklerburn

The process of obtaining a new resource consent from the ORC to take gravel from the Bucklerburn has revealed that the GCA also require permission from DoC as the land is administered by DoC notwithstanding that this hasn't been required in the past.

It may be that the usual application fees can be waived by the department but further work is needed to progress this.

Motion 'that the GCA meet with DOC staff to ascertain zero or low cost options for a concession from the department to remove gravel from the Bucklerburn"

9.6 Use of the cemetery reserve

The GCA has been approached by QLDC for comment on an application for a new grazing licence at the cemetery reserve.

The GCA replied that we had an interest in using part of the land for restoration of indigenous vegetation and potentially a native nursery but understand the land had little value for other uses due to restrictions on it as a cemetery reserve.

A recent reply has indicated that this is not necessarily correct which raises the question of what, with community support, a portion of the land could be used for?



There is current interest in finding locations around Glenorchy for natural burials, a native nursery, a science education and conservation centre and a tiny house facility.

In the circumstances it is suggested that any grazing leases issued contain a clause regarding future community use of the land and noting that this is a sensitive matter, that the GCA obtain more information about applicable rules/ constraints to enable an informed and respectful community discussion around potential uses of the portion of the land for which there will be no foreseeable need for cemetery purposes.

Motion "that the GCA request of council that any grazing leases issued at the cemetery reserve contain a clause regarding future community use of the land and that the GCA obtain more information about applicable rules/ constraints to enable an informed and respectful community discussion around potential uses of the portion of the land for which there will be no foreseeable need for cemetery purposes"
